##### Method of Recruitment

- Recruitments will be made according to the recruitment procedure of the corporation through a structured interview held by a Board of interviewers, appointed by the competent authority of appointments.
- Appointees should have to contribute 8 % and employer 12 % of the salary to Employees Provident Fund (EPF) and in addition to the above the employer will pay 3 % of the salary to Employees Trust Fund (ETF).
